Order on Appeal under Section 19 of the RTI Act, 2005

Shri Alok Chanraborty, 215, Survey Park, Block-C, Kolkata (hereinafter referred to as the Appellant) has filed the above mentioned appeal, aggrieved by the reply furnished by Section Officer (M-II) vide letter dated 7.10.2014 stating that the answer provided are vague. Through this appeal he has requested to provide information for point No. (a), (b) (c), (d) & (e) of his RTI application dated 2.9.2014.

On going through the case record, the following are observed from the records available in the Section:

(a) No such information is available. However, it is informed that the Recruitment Rule notified in 1969 for the post of Controller of Store do not classified the post as Technical however the post of designation of two posts in stream namely Asst. Store Keeper and Store Keeper has been named as Technical. Subsequent to the meeting held on 7.6.2006 it appears no action has been taken on this issue. However an High Powered Committee was constituted for 'Restructuring of GSI' in 7.1.2008 which has evaluated all the streams of GSI and the Committee submitted its report in 31.3.2009 has refer the Store stream as Asset Procure Management Division and no where it makes any recommendation for Asset Procure Management Division as a Technical Stream. The HPC report is also available in the public domain.

(b) Letter No.2355/S/A-32013/COS/2010/MSSP/19A dated 30.9.2010 was traced and it is found that it was considered in the Ministry and the relevant portion is enclosed herewith. It is also

informed that the issue of upgradation of the post of controller of stores to the level of senior administrative was considered on the basis of representation received from Shri MSSP Bhardwaj vide letter dated 28.4.2014 and the relevant extract of the note portion (5 page) is enclosed for your reference.

(c) No such proposal is traceable in which Ministry has granted relaxation of educational qualification in Recruitment Rules for promotion from the post of Dy. Controller of Stores to the post of Controller of Stores. However it is informed that this aspect was taken care of in the new Recruitment Rules of Store Stream was notified on February 2013, where educational qualification was not a bar for promotion to the post of Controller Stores.

(d & e) GSI vide letter No.A-Misc/RT/M.Msteam/2014/19A dated 27.11.2014 provided information to the applicant (copy enclosed).

With above order, the Appeal stands disposed of.
