2.	<p>Royalty system on minerals will be rationalized by adopting an ad-valorem principle wherever feasible, to make assessment and collection simpler and enhance royalty accruals to State Governments.</p> <p>The royalty rates on minerals were last revised in 2004. Since then there has been a huge expansion in mining activity particularly in relation to bulk minerals like iron ore and limestone.</p> <p>New royalty rates will be notified keeping the ad-valorem principle as the basis to the extent possible.</p>	<p>Notification revising the royalty rates issued on 13.8.09 and uploaded to Ministry's website. In keeping with Hoda Committee recommendations, rates for many minerals including Iron ore have been shifted to ad-valorem basis, meeting a long standing demand of the State Governments, whose revenues will go up substantially.</p>	100%
