Subject:- Disposal of Old and condemned cars- regarding.

The undersigned is directed to say that it is proposed to dispose of a staff cars, Registration Number DL-2CM-5325(make, 2002, Maruti Esteem).

2. Accordingly, sealed quotations are invited for the disposal of said vehicle on the terms and conditions mentioned below. Those interested, may submit their quotation in the enclosed Performa. The quotations addressed to the undersigned kept in a sealed cover should reach Ministry at the latest by 29<sup>th</sup> August, 2011 at 12:00 hrs. The quotations should be dropped in the DAK Box kept at Reception of Gate No. 2, Shastri Bhawan, New Delhi. The cover should be prominently superscribed as “QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE”. The vehicle will be available for inspection between 03:00 PM to 05:00 PM at Gate No. 2 Shastri Bhawan, New Delhi.

3. The quotations will be opened on 29<sup>th</sup> August, 2011 at 15:00 hrs. The bidders or their representative (not more than one) may remain present, if they so desire, at the time of opening of quotations.

4. The sale will be governed by the following conditions:-

- i) The bidder is required to pay Earnest Money of Rs. 5000/- (Rupees five thousand only) payable by means of Demand Draft drawn in favour of Pay and Accounts Officer, Ministry of Mines, New Delhi.

- ii) Quotations received without demand draft towards Earnest Money will not be accepted.
- iii) The successful bidder will be required to deposit the bid amount by means of cash/demand draft drawn in favour of Pay and Accounts Officer, Ministry of Mines, New Delhi within two working days of the acceptance of the bid.
- iv) Earnest Money will be forfeited if the successful bidder fails to honor the bid. The Earnest Money of the successful bidder will be released only after transfer of Vehicle Registration in his name.
- v) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status viz. Ration card/Voter identity Card/Passport in case of individual and Registration Certificate in case of firms etc.
- vi) The sold vehicle will be removed by the successful bidder from the premises of Shastri Bhawan within two working days after the issue of sale letter by this Ministry at their own expenses.
- vii) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The Ministry will not be responsible for any lapse on his part in this regard.

- viii) The vehicle will be disposed of on 'as is where is' basis and no guarantee for its worthiness or quality will be given by this Ministry.
- ix) The bidders are not allowed to withdraw their bids.
- x) The competent authority has the right to accept or reject any/all of the quotations without assigning any reason.
